1. Mahkato Mdewakanton does not guarantee sales, or issue refunds do to cancellation due to any weather related issues.
2. Refunds will not be given, if you cannot come to the Wacipi, unless your space can be filled with another vendor.
3. You may not hold the Association, its members, advisors, committee members, or anyone else associated with the Wacipi, for any injury, death or act of Nature, or any act that may occur during, before, and/or after the event.
4. If you are a food vendor sell food only no crafts... Candy sales are not allowed  
If you are a craft vendor sell crafts only no food... Candy sales are not allowed
5. If you sell any type of toy, gang related item, anything that shoots a trajectory (bows and arrows, pop guns). you will be asked to leave .....NO REFUND AND YOU WILL NOT BE INVITED BACK
6. NO BOOTH SHARING with the following exceptions
  - ✓ If you have shared a booth in the past, you must list the person vending with you and what they sell
  - ✓ If you have not shared in the past you cannot do so now.
  - ✓ NO new vendors may share a booth with another vendor
  - ✓ You have been invited to participate based on who you are and what you sell.
  - ✓ Merchandise may be sold from your booth only, no walking around selling items
7. No flashing lights, sound systems, or any other item that might disrupt the Wacipi can be used.
8. NO selling of sacred pipes, buffalo skulls, toy flutes, whistles, toys, candy, non appropriate items (to be determined by the committee).
9. Stay in the space you are provided. If you have problems of any kind, find a committee member and we will deal with the problem.
10. The highest personal conduct and integrity is expected the use of alcohol or drugs is not permitted. You will be removed if you do. Keep your area clean. Clean your area before you leave.
11. You will be given parking passes for people working for you. You may camp by your site, if approved in advance.
